


## 2019 & 2020

NepalAbility strives to advance rehabilitation in Nepal through education and improving access to therapy and equipment. The primary focus is to enhance rehabilitation for individuals living with brain injury, spinal cord injury, and other neurological impairments, but education and support are also provided for other areas in need.


The majority of the funds raised are put directly towards funding patients' therapy fees and therapeutic devices. NepalAbility has an agreement with United Mission Hospital Tansen to provide \$12,000.00 CAD annually to support patients' access to neurological rehabilitation and equipment. In 2020, this funding allowed at least 19 patients who required financial support to access inpatient rehabilitation, physio and occupational therapy services, and to purchase devices such as wheelchairs, toilet chairs, and braces. An additional 10 wheelchairs were also purchased and ready to support more patients in need.

Funding also goes towards providing education and training. A big thank you to all our educators who have volunteered their time and knowledge! Education expenses primarily include translation and interpretation costs, funding clinicians in Nepal to attend courses, and purchase of resource materials.

As NepalAbility is operated by volunteers, the administrative fee is kept very minimal. NepalAbility was successfully registered as a charity in Canada on November 2, 2020; the associated legal fee is reflected in the 2019 financial summary. The COVID-19 pandemic has put a hold on on-site visits as well as inperson fundraising event in 2020, resulting in a decrease in spending on on-site Nepal rehab and education, and a decrease in fundraising expense.




## Expense Summary



NepalAbility relies on generous donors and our fundraising events to secure funds to support Nepal. Our fundraising activities were put on hold in 2020 due to the uncertainty of the COVID pandemic; and we had also held off our online donation drive until Nov/Dec 2020 when the charity status was approved.

The net assets of NepalAbility by the end of 2020 was \$25,855.55 CAD (\$35,287.88 CAD in 2019). NepalAbility has primarily relied on revenues from previous years to sustain our commitments to support individuals living with disabilities and rehabilitation services in Nepal, especially in 2020.

With NepalAbility receiving its charity status and as we enhance our online platforms to better support remote education, training, and fundraising opportunities, we look forward to a different 2021.
